Re: Freedom of Information Act application

In reference to your application made pursuant to the *Freedom of Information Act 1991* (FOI Act), access was sought to:

"A copy of all documents and data indicating the number of fines received or issued to people for driving without registration between 19/03/2022 and 14/02/2023."

On 23 February 2023 an email was sent to your office seeking clarification of the scope of your request. On 24 February 2023, you amended the scope of your request to the following:

"A copy of a list or statistical data indicating fines received or issued to people for driving without registration between 19/03/2022 and 14/02/2023."

South Australia Police (SAPOL) has located information that falls within the scope of your request.

It should be noted that the information you seek is readily available via the Data.sa.gov.au internet site. However, the most recent statistics from 1 January 2023 to 14 February 2023 have not yet been published. As a result, these statistics have been sourced and attached separately. The documents are numbered and described in the following schedule. The schedule contains the details of the determination in compliance with section 23.
