Summary: ⁶⁽¹⁾ [redacted] kicked/damaged front doors of Pt Pirie PS, Presented with knife, restrained/tasered & spat in face of SAPOL member.

Narrative: *Entry Time:* 07/11/2022 20:46 *Entry:*
At about 6:20pm on Monday the 7th of November 2022, Police were alerted to the locked front station doors to loud thud.

Upon inspection overserved that ⁶⁽¹⁾ [redacted] had kicked and smashed one of the front glass sliding doors.

⁶⁽¹⁾ [redacted] resisted arrest and was tasered (drive stun) twice and eventually handcuffed to the rear.

While being walked to the cells, ⁶⁽¹⁾ [redacted] hacked and spat in the face of Police BATZAVALIS.

⁶⁽¹⁾ [redacted] placed in padded cell before being conveyed to Port Pirie Regional Hospital for a mental health assessment.

ACTION AT SCENE

Police attended to loud bang at the front station and attempted to arrest ⁶⁽¹⁾ who resisted heavily. ⁶⁽¹⁾ was tasered twice (NICHOLSON) and was hand cuffed to the rear. Was searched when under control and located a knife in his pant pocket.

Place in padded cell and was conveyed to Port Pirie Regional Hospital shortly after for a mental health assessment and is still currently there.
