Dear Mr Telfer

In reference to your application made pursuant to the *Freedom of Information Act 1991* (FOI Act), access was sought to:

"Access to the review into regional policing undertaken by SAPOL, mentioned by the Minister in his answer during Question Time on Tuesday March 7th 2023 as follows: "My question is to the Minister for Police, Emergency Services and Correctional Services. Has the review by the Premier's taskforce into regional policing been completed and presented to cabinet yet? Thank you to the Member for Flinders for his question. The taskforce hasn't completed the work undertaken as was put by the member. The review into regional policing was in fact completed, and that work was undertaken wholly and solely by the police commissioner and by police as is their operational imperative."

This request is very broad in nature and without nominating a specific artefact, South Australia Police (SAPOL) consider the following documents as falling within the scope of your request. The documents are numbered and described in the following schedule. The schedule contains the details of the determination in compliance with section 23. In particular, note the grounds on which access has been refused, including the reasons which are contained in the schedule.

Clause 9(1)(a)(i), 9(1)(a)(ii) & 9(1)(b) of Schedule 1 of the FOI Act which states:

"A document is an exempt document if it contains matter that relates to any opinion, advice or recommendation that has been obtained, prepared or recorded; or any consultation or deliberation that has taken place, in the course of, or for the purpose of, the decision-making functions of the Government, a Minister or an agency; and the disclosure of which would, on balance, be contrary to the public interest".
