**Re: Freedom of Information Act application**

I refer to your application made pursuant to the Freedom of Information (FOI) Act 1991 in which access was sought to the following information:

*"I'm seeking documents each year, since 1 January 2017, specifically incident/event reports and related CCTV/dash cam/body-worn camera/mobile phone camera/video footage where the charges include (at least) dangerous driving and possessing dangerous good in a vehicle. I confirm I consent to being provided edited copies of documents/footage with personal information such as names and faces redacted/pixelated/blurred."*

On 17 September 2018, I requested clarification via email regarding the scope of your request. On the same date, you advised by email, "All the other police agencies did searches where both those charges existed, so there would be much fewer captured. Please limit to just reports and related photos/CCTV/video footage/pol air where someone has been charged for both dangerous driving and possessing dangerous good in vehicle."

On 27 September 2018, I advised you by email that searches had revealed over 30 reports that fall within the revised scope of your request. I requested that you amend your request to a list of the offences and 10 reports. On 1 October 2018 you replied via email: "I recognise you'll have to consult the relevant area within your organisation to find how many have legal action pending, which would reduce it more and in other jurisdictions, I regularly receive 30 reports back with an FOI release. However, I'm happy to receive a list and a maximum of 10 reports (with those reports where legal action is pending to be excluded). But in relation to the narrowing of which 10 reports would be included, I ask that they at least have CCTV and if there aren't 10 that do, that the remainder at least include photos. I ask for searches to be undertaken in order from oldest to newest."

Before dealing with your request it is important to draw your attention to the page numbers on the top right corner of each document. The page numbers relate to the number of pages printed with each batch print run and are not indicative of the number of pages associated with each report.





South Australia Police (SAPOL) has located documents that are associated with the wording of your FOI application. The documents are numbered and described in the following schedule. The schedule contains the details of the determination in compliance with section 23. In particular, note the grounds on which access has been refused, including the reasons which are contained in the schedule.

## CLAUSES FOR REFUSAL

Clause 6(1) of Schedule 1 of the FOI Act which states:

*"A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead)."*

Clause 6(2) of Schedule 1 of the FOI Act which states:

*"A document is an exempt document if it contains allegations or suggestions of criminal or other improper conduct on the part of a person (living or dead) the truth of which has not been established by judicial process and the disclosure of which would be unreasonable."*

Clause 6(3a) of Schedule 1 of the FOI Act which states:

*"A document is an exempt document if it contains matter consisting of information concerning a person who is presently under the age of 18 years or suffering from mental illness, impairment or infirmity or concerning such a person's family or circumstances, or information of any kind furnished by a person who was under that age or suffering from mental illness, impairment or infirmity when the information was furnished and the disclosure of which would be unreasonable having regard to the need to protect that person's welfare."*

Clause 11(b) of Schedule 1 of the FOI Act which states:

*"A document is an exempt document if it contains matter prepared for the purposes of proceedings (including any transcript of the proceedings) that are being heard or are to be heard before a court or tribunal."*

In accordance with the requirements of Premier and Cabinet Circular PC045, details of your FOI application, and the documents to which you are given access, will be published on the SAPOL website Disclosure Log. 
