**Re: Freedom of Information Act application**

In reference to your application made pursuant to the Freedom of Information (FOI) Act 1991, access was sought to:

*“A copy of SAPOL General Orders on Custody Management.”*

On 15 August 2019 I spoke with Mr Andrew Love via telephone and during our conversation he amended and narrowed the scope of your application to seeking access to:

*“General Order - Custody Management, General Order - Arrest/Report Procedures, General Order - Deaths in Custody and General Order - Youth Justice specifically, with respect to SAPOL notifying ALRM of persons arrested and/or in custody.  
All other text to be excluded from the scope.”*

It should be noted that a large portion of text in all documents scheduled below has been redacted and marked as **Out of Scope** as it does not fall within the amended and narrowed scope of this application.
