Re: Freedom of Information Act application

In reference to your application made pursuant to the Freedom of Information (FOI) Act 1991, access was sought to:

"Copies of any documents (including but not limited to hard copy or electronic briefings, minutes, reports, emails, letters and any other correspondence) that confirm the total number and location of speeding expiation notices issued by SAPOL within the Town of Gawler Council area and also the total expiation revenue raised."

On 18 August 2020 via email you were advised that data falling within the scope of your request was available on DataSA however only identified the expiation location by police district and not council area. You agreed to refine the scope of your application to seeking data by postcode.

It is determined that a total of 741 Expiation Notices for speed related offences for the postcode 5118 have been issued between 1 July 2019 and 30 June 2020 with a face value of \$418,630. This data was correct as at 12.05 pm on Tuesday 18 August 2020 and specific speed related offences have been presented in the table below.

Your rights to review

If you are dissatisfied with the determination for access to SAPOL records, you are entitled to exercise your right of internal review in accordance with section 29(1) of the FOI Act by completing a PD362 Application for Internal Review form which can be downloaded from <https://www.police.sa.gov.au/services-and-events/freedom-of-information> or available upon request at your nearest police station. Alternatively an application may be made in writing to the SAPOL Freedom of Information Unit. This application must be lodged within 30 days from the date of this determination with a fee of \$37.50. Such a fee may be waived in the event of an exemption being claimed.
