Re: Freedom of Information Act application

In reference to your application made pursuant to the Freedom of Information (FOI) Act 1991, access was sought to:

Ollic,

"Documents since 1 January 2019, specifically reports and related AV material (including bodyworn camera and cameras, mobile phone camera, pol air and police vehicle cameras, other video footage captured) relating to people being charged for evade police and failing to stop for police. If footage of more than 10 incidents are captured, please limit to just those 10 incidents where footage is located along with the related incident reports. Please do searches for footage chronologically starting with those in 2019. If different types of footage is captured, please include all footage. Please exclude those where legal action is pending. Please exclude duplicates, documents that have already been released publicly, media reports/articles/statements and correspondence with media. Please note I confirm I am happy to accept edited copies of documents/footage/photos with exempt material redacted/pixilated/cropped."

On 9 December 2020 in an email to Sergeant Sandra Watson you narrowed the scope of your request to Custom Occurrence Reports.

In making this determination it should be noted parts of the document that do not fall within the scope of your application have been redacted and marked as **Out of Scope**. It should be further noted regarding audio visual material document 1A is visual only.

It should be further noted on 10 November 2020 a Third Notice of Estimated Costs was emailed advising costs had been fully spent with five (5) documents being discovered that fall within the scope of your application. Payment of charge was required by 10 December 2020 and was not received.

This determination was made on 15 December 2020.
