## Re: Freedom of Information Act application

In reference to your application made pursuant to the Freedom of Information (FOI) Act 1991, access was sought to:

2.1C

"All documents (including but not limited to physical, electronic, or written briefs, internal discussion papers, minutes, emails, diary entries and any other correspondence) referencing all costs associated with operating police stations, broken down by location of police station and opening hours. From 25/03/2018-02/03/2021"

On Wednesday 10 March 2021 Senior Sergeant First Class Gentgall spoke with of your office to clarify the scope of application. In an email dated 12 March 2021 refined the scope to seeking access to:

"Any documents referencing costs associated with the utility (rent, gas, water, electricity) costs for each police station broken down by financial years. Time frame 25/03/2018 – 02/03/2021."

On Monday 24 March 2021 Sergeant Watson spoke with of your office regarding the scope of your application. In an email sent on the same date refined the scope to seeking access to;

"Any documents referencing costs associated with the utility (rent, gas, electricity) cost for SAPOL metropolitan districts.

Any documents referencing costs associated with utility (rent, gas, electricity) cost for SAPOL Country Local Service Areas if possible to include each police station. Broken down by financial year 2018/2019 and 2019/2020."
