National & State Security & Governance	Level 4	<ul style="list-style-type: none"> <li>COVID-19 test on day 1, 5, &amp; 13.</li> <li>Self-quarantine unless performing the duties, functions or activities of the category, or travelling to and from performing the duties, functions or activities for 14 days.</li> <li>Must wear a face mask (covering mouth and nose) at any time that they come into contact with the public for a period of 14 days after their arrival in South Australia.</li> </ul>

Commercial Transport and Freight Services	Level 4	<ul style="list-style-type: none"> <li>Category 1:               <ul style="list-style-type: none"> <li>Must have evidence of having a COVID-19 test within the last 48hrs or must have a COVID-19 test within 24hrs of arrival and must QR Code at testing station upon entry.</li> <li>No self-quarantine</li> <li>Must not enter a high risk setting for 14 days.</li> </ul> </li> <li>Must wear a face mask (covering mouth and nose) at any time that they come into contact with the public for a period of 14 days after their arrival in South Australia.</li> <li>Category 2:               <ul style="list-style-type: none"> <li>Must have evidence of having a COVID-19 test within the last 48hrs or must have a COVID-19 test within 24hrs of arrival and must QR Code at testing station upon entry.</li> <li>Self-quarantine unless performing the duties, functions or activities of the category, travelling to and from performing the duties, functions or activities.</li> <li>Must wear a face mask (covering mouth and nose) at any time that they come into contact with the public for a period of 14 days after their arrival in South Australia.</li> </ul> </li> </ul>
Remote or Isolated Worker	Level 4	<ul style="list-style-type: none"> <li>Category 1:               <ul style="list-style-type: none"> <li>COVID-19 test on day 1, 5, &amp; 13.</li> <li>No self-quarantine</li> <li>Must not enter a high risk setting for 14 days.</li> <li>Must wear a face mask (covering mouth and nose) at any time that they come into contact with the public for a period of 14 days after their arrival in South Australia.</li> </ul> </li> <li>Employer must have a compliant risk mitigation strategies in place during the periods of work.</li> <li>Category 2:               <ul style="list-style-type: none"> <li>COVID-19 test on day 1, 5, &amp; 13. Unless they can produce evidence of a COVID-19 test.</li> <li>Self-quarantine unless performing the duties, functions or activities of the category, travelling to and from performing the duties, functions or activities.</li> <li>Must wear a face mask (covering mouth and nose) at any time that they come into contact with the public for a period of 14 days after their arrival in South Australia.</li> <li>Employer must have a compliant risk mitigation strategies in place during the periods of work.</li> </ul> </li> </ul>
Cross Border Community Members 70km either side of the border between SA and VIC	No Level	<ul style="list-style-type: none"> <li>People who ordinarily reside in the VIC cross border corridor may enter South Australia if they have reasonable cause to travel for any purpose, provided they:               <ul style="list-style-type: none"> <li>Remain in the cross border corridor while not in South Australia (i.e. do not travel beyond 70km of the South Australian border into broader Victoria for any purpose); and</li> <li>Have not, during the period of 14 days before entering South Australia from the Victorian cross border corridor, been associating (in person) with persons from broader Victoria or other restricted zones outside of the cross border corridor.</li> </ul> </li> <li>Residents who travel beyond the cross border corridor will need apply as a permitted arrival or essential traveller on return.</li> </ul>
Specialist Workers in Essential Sectors	Level 4	<ul style="list-style-type: none"> <li>COVID-19 test on day 1, 5, &amp; 13.</li> <li>Self-quarantine unless performing the duties, functions or activities of the category, or travelling to and from performing the duties, functions or activities for 14 days.</li> <li>Must wear a face mask (covering mouth and nose) at any time that they come into contact with the public for a period of 14 days after their arrival in South Australia.</li> <li>Employer must have a compliant risk mitigation strategies in place during the periods of work.</li> </ul>
Passing Through	Level 4	<ul style="list-style-type: none"> <li>COVID-19 test on day 1, 5, &amp; 13.</li> <li>Self-quarantine unless travelling</li> <li>Must wear a face mask (covering mouth and nose) at any time that they come into contact with the public for a period of 14 days after their arrival in South Australia.</li> <li>Must have evidence of entry into the receiving state.</li> <li>Can not be in SA for more than 72 hours</li> <li>Must not remain overnight or for longer than 1hr in Coober Pedy, Pt Augusta or Ceduna</li> <li>Must avoid non-essential contact with people in SA</li> </ul>
Foreign Diplomatic or Consular Staff	Level 4	<ul style="list-style-type: none"> <li>COVID-19 test on day 1, 5, &amp; 13.</li> <li>Self-quarantine unless performing the duties, functions or activities of the category, or travelling to and from performing the duties, functions or activities for 14 days.</li> <li>Must wear a face mask (covering mouth and nose) at any time that they come into contact with the public for a period of 14 days after their arrival in South Australia.</li> </ul>
