Re: Freedom of Information Act application

If that exists, we'd be happy to limit to only that, along with a list of jobs that officers applied to do (as a second job) or were already doing which did not have the consent of the agency, or were refused permission. Please exclude duplicates, documents that have already been publicly released, media statements/reports/articles and correspondence with media. I consent to documents/video beings released with exempt material redacted/pixilated. I don't consent to being provided edited copies of documents/photos/footage with personal information redacted/pixilated.."

It is determined to **release in full** a list of the number and type of approved and declined secondary employment for South Australia Police Officers since 1 January 2019 as provided in previous years. The information has been presented in a table below and was correct as at 20 August 2022.
