Notes: The increase in reported Common Assault offences, reflects a continuing historical refinement to SAPOL reporting processes more than an increase in offences.

The current increases in recorded crime, most notably Offences Against Property, largely reflect a return to the pre-Covid level of recorded crime prior to Covid related community based restrictions, which included restricted community activity and a reduction in business operations. The 2018/19 Pre-Covid period has been included to show context to current figures.
