Domestic Abuse Incident Actions

ACTION AT SCENE

At about 1155hrs on Friday the 11th of March 2025, Police HAYTER/MAURICI were conducting a walkthrough of the Flinders Hotel, PORT AUGUSTA and observed the accused standing in the gaming room with a backpack.

Police conducted a metal detector wand screen of ^{Out of Scope} backpack which returned a positive indication. Police required ^{Out of Scope} to produce the items in his backpack detected by the metal detector and conducted further screens to ensure no further metal items were present. Police also screened ^{Out of Scope} person, which resulted in the location of one half of a pair of medical scissors in his right short pocket.

^{Out of Scope} stated during ROI on BWV that he used the scissors for sharpening pencils, however he did not have any pencils in his possession at the time and stated that they were at home. Police reported ^{Out of Scope} for COW in LP and seized the scissors.
