Re: Freedom of Information Act application

I refer to your application received by South Australia Police (SAPOL) in which access was sought to the following information:

"Documents, specifically executive briefings and attachments, reports, bodyworn camera/taser /CCTV/video footage, since 1 January 2017, relating to illicit drug laboratory raids where footage has been captured and there is no legal action pending. Please include statistics of the number of drug laboratory raids and related districts for 2016 and 2017. I also request that if more than one briefing is captured on the same subject, please only include the most recent. Please exclude duplicates, documents that have already been publicly released, media statements /reports/articles and correspondence with media. Please exclude documents that have already been publicly released."

On 5 March 2018, Sergeant Friend emailed you to narrow the scope of your request. You narrowed the scope to, "a list for 2016 and 2017 and still search for footage...even if its just footage of one raid....".

South Australia Police (SAPOL) has located documents that are associated with the wording of your FOI application. The documents are numbered and described in the following schedule. The schedule contains the details of the determination in compliance with section 23. In particular, note the grounds on which access has been refused, including the reasons which are contained in the schedule.

This application must be lodged within 30 days from the date of this determination with a fee of \$34.25. Such a fee may be waived in the event of an exemption being claimed.
