Adelaide Oval - Response to Intervention and Submissions

- 1. Adelaide Oval SMA Limited (AOSMA) has applied for a variation of a condition to Liquor Licence 57102633 (Licence), in accordance with section 70 of the *Liquor Licensing Act 1997*, to facilitate service of alcohol in cans (with a 6 month trial period) (Application).
- 2. It is important to note that no submission has been received from either the public or Adelaide City Council in respect to the Application. In addition, Adelaide City Council has confirmed by email dated 21 June 2022 (copy enclosed) that AOSMA will not require any development approval or variation to an existing approval, and may proceed without the need for any further consent/approval from Council.
- A Notice of Intervention dated 16 June 2022 has been lodged by South Australian Police, and SAPOL has provided a letter from the Police Association of South Australia dated 6 July 2022 (Notice).
- 4. SAPOL have intervened on the basis of being concerned about public interest, arising from a threat to public safety that would exist in the event of a public disturbance occurring at Adelaide Oval that results in cans being thrown in public areas and the playing arena.
- 5. AOSMA acknowledges the importance of maintaining public safety at all times, and the implementation of appropriate measures where necessary to protect against threats to public safety. We respond to the matters contained in the Notice and provide additional submissions as follows.

Historic and isolated incidents

- The Notice refers to two examples where behavioural concerns have occurred in Australia, one being an incident at the Sydney Cricket Ground in 1971 and the other an incident at Lang Park (now Suncorp Stadium) in Brisbane, in 1989.
- 7. These are historical incidents occurring 51 and 33 years ago. It is respectfully difficult to see the relevance of these isolated incidents, other than that concerns with respect to safety have historically existed due to isolated incidents. No further information or context has been provided regarding the control measures employed in relation to those incidents at the time (which we suggest are likely to be nothing similar to today's standards).

8. In the 1970's and 1980's, the alcohol/venue management plans, framework and arrangements were significantly different to present day Adelaide Oval. AOSMA is confident that its current safety, service and monitoring arrangements are sufficient to effectively manage any concerns or risks that may arise. This is discussed further below.

Appropriate measures

- 9. AOSMA is of the view that aluminium cans present no greater risk of use as a projectile than that currently existing from water bottles, soft drink bottles, and plastic cups. In fact, plastic cups can present a more likely used projectile given the spray effect from throwing a cup. This view is reinforced by the successful trials of service in cans at other major sporting grounds in Australia (discussed further below).
- 10. AOSMA already serves alcohol in cans in its corporate, dining, reception and function areas, including open corporate boxes which are located in 4 locations within the members and general admission areas. AOSMA has not experienced any incidents of concern.
- 11. Adelaide Oval generally enjoys very good crowd behaviour for a venue of this capacity and event type. However, to prevent and manage behavioural incidents, AOSMA currently maintains a significant presence of security personnel, in conjunction with real time CCTV monitoring, attendance of SAPOL on gamedays, as well as usual responsible service of alcohol procedures.
- 12. AOSMA and SAPOL already work together to ensure that incidents are minimised, and when they do occur, are managed appropriately. As has always been the case, in the event any issues of crowd safety or behaviour arise, AOSMA takes immediate and proactive steps to ensure they are effectively managed. On this basis, AOSMA is confident that its current security arrangements and approach to responsible service of alcohol are sufficient to manage any concerns that may arise from implementation of this application.
- 13. However, AOSMA are proposing an initial 6 month trial period in order to address any issues that may arise before the variation becomes permanent. This will ensure that the service in cans can be monitored to ensure it is undertaken in a responsible manner, and any incidents arising are addressed quickly by AOSMA, SAPOL and the Commissioner.
- 14. Within the initial six-month trial period, AOSMA (and SAPOL) will continue to monitor all behavioural and safety risks and incidents, particularly any associated with the service of alcohol in cans. AOSMA will consult with CBS and SAPOL, who are welcome to raise concerns with AOSMA at any time during the trial. If raised, AOSMA commits to addressing those concerns in co-operation with SAPOL proactively and in a timely manner.
- 15. We emphasise that AOSMA never intends to place its liquor licence at risk, and will not jeopardise its regulatory compliance record. The security arrangements, and responsible service of alcohol framework, ensure that Adelaide Oval is a suitable and controlled environment for service in cans.
- 16. We reiterate the below benefits arising from service in cans (which may not have been fully addressed by SAPOL in their intervention and which clearly demonstrates there are in fact benefits from service of alcohol in cans both with respect to responsible service and crowd management):
 - a. The service of alcohol in cans provides an improved ability to ensure responsible service and consumption of alcohol. Cans have a smaller volume than the current plastic cups, resulting in a reduced quantity of alcohol supplied (and consumed) upon each purchase.
 - b. The smaller volume of liquid provided will also lead those patrons who are wanting to consume a large quantity of alcohol to more frequent attendance at service points, which provides a greater opportunity for AOSMA staff and security to identify and manage patrons who present a potential concern.
 - c. In addition, cans have a reduced ability for quick consumption given their narrower outlet.

d. The use of cans also allows for a greater all-round patron experience. Cans have less risk of spillage and are easier to transport to and from service points to seated areas. It also allows stadium management to explore further commercial opportunities with service providers who produce in cans only.

Victoria Police and sale in cans at other events

- 17. The Notice includes a response from Victoria Police in relation to concerns raised about the reintroduction of aluminium cans at Victorian sporting venues.
- 18. We understand that the service of alcohol in cans at both the MCG and Marvel Stadium has been well received and whilst incidents relating to alcohol have still occurred, these are not attributable to service in cans. One incident is referred to in the Victoria Police comments that has apparently been raised after the event, and with no context. It is entirely unclear whether this isolated incident would have occurred regardless of whether alcohol was served in cans or otherwise.
- 19. Again, concerns raised by Victoria Police are due to historic incidents and without any regard to current safety and management standards.
- 20. AOSMA's Security Manager recently attended a stadiums security forum. The sale and distribution of cans was discussed. Adelaide Oval is currently the only major stadium in Australia that has not been granted approval for the use of cans (other than corporate areas). Consensus received from all stadiums since the introduction of cans was that there have been no crowd behaviour issues arising from service in cans.
- 21. We also note our understanding that other major sporting and cultural events in South Australia facilitate service of alcohol in cans, which events are of longer duration and with substantially greater capacity than those conducted at Adelaide Oval. The potential use of cans as projectiles at those events appear to have been well managed.

Alternatives and Government Support

- 22. The Notice proposes alternative drink containers, being biodegradable plastic cups, and 'Draft Top' cans. Whilst AOSMA appreciates the suggestions, unfortunately neither is an appropriate alternative at this time.
- 23. Enquiries have been made of AOSMA's contracted supplier who has advised that 'Draft Top' cans are not facilitated, and will not be in the foreseeable future. We also note that AOSMA is considering the potential for future sale of non-alcoholic (carbonated) soft drinks in cans.
- 24. In paragraphs [24] and [25] of our initial submission, we noted that the variation proposal enjoys State Government support.
- 25. AOSMA has recently received a letter from the Hon Susan Close MP, Deputy Premier and Minister for Climate, Environment and Water, on 6 June 2022. Please see that letter enclosed.
- 26. Minister Close is supportive of the variation proposal and its environmental benefits.

Approach to Assessment

27. Examples of prior incidents that have been raised are historic, isolated, with no context of management practices in place at the time, and without regard to current alcohol management standards. Service in cans in public areas has been successfully trialled at other major sporting grounds in Australia, and already occurs in corporate, dining, reception and functions areas (including open boxes) at Adelaide Oval. No concern has been raised by any member of the public or Council in respect to the Application.

- 28. AOSMA is of the view that service of alcohol in cans presents no higher threat to safety than current practices. However, AOSMA is also willing to commit to the following to ensure the Commissioner can be comfortable that appropriate measures will be in place to protect against any increased threat to public safety arising from this Application:
 - a. AOSMA is comfortable that its extensive current alcohol management practices (including presence of security, SAPOL, CCTV monitoring, and responsible service procedures) will ensure that service of alcohol in cans can be effectively managed.
 - b. AOSMA is willing to commit to a 6 month trial period.
 - c. AOSMA will consult with the Commissioner and SAPOL, who are welcome to raise concerns with AOSMA at any time during the trial. If raised, AOSMA commits to addressing those concerns in co-operation with SAPOL and the Commissioner proactively and in a timely manner.
 - d. The trial can of course be reviewed at any time by the Commissioner should he be of the view that is necessary.
 - e. AOSMA is comfortable that there are significant benefits to be gained from service of alcohol in cans, including with respect to responsible service and management of crowd behaviour.


