**“A copy of all data indicating the total number and the type of incidents reported to SAPOL (including times SAPOL were called to attend) at Elizabeth Shopping Centre, Westfield Marion, Armada Arndale, Westfield Tea Tree Plaza, and Rundle Mall between January 1 2024 and 26<sup>th</sup> November 2024.”**

To demonstrate the above request, data relative to offences reported to SAPOL as well as South Australian Computer Aided Dispatch (SACAD) events for Police attendance have been provided for the above-mentioned locations. It is not possible to correlate offences reported to SAPOL with SACAD events for Police attendance and as such the data sets should be considered separately.

The below figures demonstrate the number and type of offences reported to Police at Elizabeth Shopping Centre, Westfield Marion, Armada Arndale, Westfield Tea Tree Plaza and Rundle Mall for the period of 1 January 2024 to 26 November 2024. The accuracy of the data relies on the correct recording of the offence location to the street address of the shopping centre.
