At about 1700hrs on Sunday 5th of March 2023, police STAPLES/LONGDEN responded to CAD tasking 1591 where call centre⁶⁽¹⁾ stated that she was making an attempt to exit the front doors at the SA police headquarters when she was confronted by the accused.

The accused is alleged to have been kicking the doors violently in an attempt to get into the building although ⁶⁽¹⁾ states that she made all attempts to advise the accused that SA police headquarters is not an operating station.

The accused was described as being caucasian, male, bail with some hair on top, dark brown hair, wearing black shorts, black t-shirt with sandshoes and no socks.

Police Security Cameras have captured the accused kicking the doors. The accused is also on current bail not to attend SA police headquarters.

Police located the accused matching the description as states at <u>CARRINGTON ST and ST HELENA PL</u>. <u>ADELAIDE SA Australia</u> where he was extremely aggressive and anti police.
