Re: Application for access to South Australia Police (SAPOL) records

In reference to your application made pursuant to the Freedom of Information (FOI) Act 1991, access was sought to:

"Hi I'm requesting the number of guns seized (and or other weapons) by police from homes over the past 3 years. Can you include a breakdown of which suburb and include possible pictures of the weapons as examples."

On 24 September 2018, I had a telephone conversation with you regarding the scope of your request. You agreed to narrow the scope of your request to statistics showing when a person is arrested or reported for unlawful possession of a firearm, including the Local Service Area / Police District where the offence occurred for the last 3 financial years. For your convenience I have also included a summary table of that data.

It is determined to **release in full** the statistical information regarding the arrest or report details regarding unlawful possession of a firearm inclusive of both Firearms Act 1977 and Firearms Act 2015. This information is contained within the table below and was correct as of 28 September 2018.
