Re: Freedom of Information Act application

In reference to your application made pursuant to the Freedom of Information (FOI) Act 1991, access was sought to:-

"For each reporting year 2015, 2016 and 2017

- 1. The number of police officers who have:
a. Retired; b. Resigned; and c. Been dismissed*
- 2. For each of the above;
a. The age of the officer, b. the reason for leaving and, c. the number of years of employment."*

On 23 November 2017 I telephoned your office and spoke with [REDACTED]. I advised that South Australia Police could not extract individual/unique reasons for each Police Officer that retired, resigned or who had been dismissed, as current systems are limited to record six (6) predefined types of separation; that fall within the scope of your request. They are *Age Retirement, Resigned, Resigned Ill Health, Invalidity, Death and Dismissed*. [REDACTED] narrowed the scope of your request to seeking:

'data that can be extracted from current systems.'

It is determined to **release in full** the number of Police Officers who have retired, resigned or been dismissed, including age, predefined type of separation and number of years employed for 2014/2015, 2015/2016 and 2016/2017. The data has been presented in tables below and was correct as at 13 November 2017.


