Re: Freedom of Information Act application

In reference to your application made pursuant to the Freedom of Information (FOI) Act 1991, access was sought to:

"I request documents relating to motorists caught speeding in school zones. Specifically I'm seeking reports, correspondence such as emails, briefing notes and attachments containing the following information: 1. The number of motorists caught speeding through speed zones in SA in 2020 and 2021 (to date) respectively. 2. A breakdown of how far they were over the speed limit. Ie. 10km/h or less, 15km/h or less, 20km/hr or less, 20km/h-plus. 3. The top 10 places in Adelaide where they were caught speeding and a breakdown of how many were caught for each in the past year. 4. The top 5 lead foots (ie. motorists travelling the most over the speed limit) including how fast they were going, where and when they were caught. Please exclude duplicates, documents that have already been publicly released, and media reports/articles/statements. Please note I do not consent to any documents being deemed irrelevant without consultation."

I refer to your email dated 21 July 2021 in which you narrowed the scope of your application to seeking access to:

- "I request statistical information relating to motorists caught speeding in school zones. Specifically
- 1. The number of motorists caught speeding through speed zones in SA in 2020 and 2021 (to date of application 9 June 2021) respectively.
- 2. A breakdown of how far they were over the speed limit. ie. 10km/h or less, 15km/h or less, 20km/hr or less, 20km/h-plus.
- 3. The top 10 places in Adelaide where they were caught speeding and a breakdown of how many were caught for each in the past year.
- 4. The top 5 lead foots (ie. motorists travelling the most over the speed limit) including how fast they were going, where and when they were caught."



In relation to the following part of your request:

"...1.The number of motorists caught speeding through speed (school) zones in SA in 2020 and 2021 (to date of application 9 June 2021) respectively. ..."

It is determined between 1 January 2020 and 31 December 2020 three hundred and four (304) expiation notices were issued for speeding in a school zone.

It is determined between 1 January 2021 and 9 June 2021 one hundred and eleven (111) expiation notices were issued for speeding in a school zone.

This information was correct as at 16 July 2021.

In relation to the following part of your request:

"...2. A breakdown of how far they were over the speed limit. ie 10 km/h or less, 15 km/h or less, 20km/hr or less, 20 km/h plus ..."

It is determined to **release in full** data that falls within this part of your request. The data has been presented in the table below and was correct as at 16 July 2021.
