Re: Freedom of Information Act application

In reference to your application made pursuant to the Freedom of Information (FOI) Act 1991, access was sought to:

"For the following financial years: 2014/15 2015/16 2016/17 2017/18 and between 1 July 2018 to 31 October 2018 The number of vehicles clamped, impounded or forfeited under the Criminal Law (Clamping, Impounding and Forfeiture of Vehicles) Act 2007. The number of offences and the types of offences committed for vehicles clamped, impounded or forfeited under the Criminal Law (Clamping, Impounding and Forfeiture of Vehicles) Act 2007."

On 6 December 2018, I had a telephone call with your Chief of Staff, John regarding the scope of your request. I advised him that South Australia Police (SAPOL) do not hold figures that relate to forfeited vehicles as these statistics are held by the Courts Administration. John advised that he would be happy to narrow the scope to "statistics relating to clamped and impounded vehicles only".

In relation to Part 1 of your request:

"For the following financial years: 2014/15 2015/16 2016/17 2017/18 and between 1 July 2018 to 31 October 2018 The number of vehicles clamped, impounded or ... under the Criminal Law (Clamping, Impounding and Forfeiture of Vehicles) Act 2007. ..."

It is determined to **release in full** the statistical information regarding the number of vehicles clamped or impounded by SAPOL for the past 5 financial years up to 31 October 2018. This information is contained within the table below and was correct as of 4 December 2018.

This must be lodged within 30 days from the date of this determination with a fee of \$35.00. Such a fee may be waived in the event of an exemption being claimed.
