Dear Sir,

In reference to your application made pursuant to the Freedom of Information (FOI) Act 1991, access was sought to:

*"Copies of any and all documents and correspondence (including but not limited to physical, electronic, or written letters and briefs, minutes, emails, diary entries, meeting notes and any other correspondence) from 19 March 2019 regarding savings targets and initiatives being considered and or implemented by SAPOL.."*

On 13 June 2019, you were advised in writing, pursuant to Section 18 of the FOI Act that your request was considered to be too broad and would unreasonably divert the resources of this agency by searching throughout South Australia Police (SAPOL) for document/s that may fall within the scope of your request. You were invited to narrow the scope of your request. On 18 June 2019 SAPOL received an email from your office:

*"Could we please amend the scope between the Business Service, Commissioner and the Minister".*

Please note that email accounts of the Commissioner of Police, SAPOL Staff Officers, Director of Business Service and ministerial correspondence was searched in order to discover documents that fall within the scope of your request. Search dates were restricted to 19 March 2019 to 4 June 2019, both dates inclusive and keyword searches were restricted to the words, 'savings, targets and initiatives'.

On 17 July 2019, SAPOL consulted with the Attorney-General's Department (AGD), concerning some of the documents in scope. SAPOL sought their views regarding the disclosure of information concerning their agency. As at the date of this determination no response has been received from AGD.

SAPOL has located documents that fall within the scope of your request. These documents are numbered and described in the following schedule. The schedule contains the details of the determination in compliance with section 23. In particular, note the grounds on which access has been refused, including the reasons which are contained in the schedule. This determination was made on 17 July 2019.


*"A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead)."*

If you are dissatisfied with the determination for access to SAPOL records, you are entitled to exercise your right of internal review in accordance with section 29(1) of the FOI Act by completing a PD362 Application for Internal Review form (available upon request at your nearest police station), or an application may be made in writing to SAPOL Freedom of Information Unit. This must be lodged within 30 days from the date of this determination with a fee of \$36.75. Such a fee may be waived in the event of an exemption being claimed.

Exceed signed by 45 km/h or more	\$ 1,036	60%	\$ 1,710	Includes the 5% Govt

**Part 5 of the Road Traffic Act**

Part 5 of the RTA provides for offences relating to speeding while driving a road train which weren't included in the figures originally submitted to DTF.

The fines for speeding in a road train under the fee increases would be as follows:

Exceeding the prescribed speed limit while driving a road train

	Current Fee	Increase	New Fee
Exceed signed speed by 1 – 9 km/h	\$ 460	2%	\$ 469
Exceed signed speed by 30 – 44 km/h	\$ 1,036	5%	\$ 1,088
Exceed signed by 45 km/h or more	\$ 1,101	5%	\$ 1,156

Exceeding the speed limit in a built up area (under 90 km/h) in Orroroo, Peterborough, Port Augusta and Whyalla while driving a road train

	Current Fee	Increase	New Fee
Exceed signed speed by 1 – 9 km/h	\$ 174	2%	\$ 178
Exceed signed speed by 30 – 44 km/h	\$ 920	5%	\$ 966
Exceed signed by 45 km/h or more	\$ 1,036	5%	\$ 1,088

This would create the situation where people detected speeding at 30 km/h or more over the speed limit in a light vehicle would get a higher fine than those detected speeding in a road train. However, speeding in a road train creates a far greater risk.

A search by Expiation Notice Branch provided that in the 2017/18 year, there were 365 expiation notices issued for a road train exceeding the speed limit by 45 km/h or more where it was detected exceeding the speed limit in a built up area (under 90 km/h) in Orroroo, Peterborough, Port Augusta and Whyalla.

The following tables display the number of expiations issued to road trains under Part 5 of the RTA.

Exceeding the prescribed speed limit while travelling in a road train

It is recommended the fee increases approved by DTF are also applied to part 5 of the RTA (speeding offences in a road train) in the same way that speeding offences are applied to part 3 of the RTA.

This will provide a level of consistency in relation to issuing expiations for all speeding motorists.
