Re: Freedom of Information Act application

In reference to your application made pursuant to the Freedom of Information (FOI) Act 1991, access was sought to:

"Are you able to provide a breakdown of how many times tasers have been discharged and or drawn by SA Police Officers between July 2016 and July 2020? In addition how many times an officer has drawn or fired their handguns during the same period. Can you also provide up to four examples of new body worn/taser cctv/ video footage of a taser being discharged and hitting an offender? I confirm I consent to being provided edited copies of documents/footage with personal information such as names"

On 26 March 2021 in an email to Sergeant Sandra Watson, clarified the scope of the application to seeking access to:

"Statistical data on how many times tasers have been discharged and or drawn by SA Police Officers, how many times an officer has drawn or fired their firearm. Time period financial years 2016/2017, 2017/2018, 2018/2019 and 2019/2020. A random selection of four (4) AV materials of tasers being drawn and discharged. I consent to being provided with edited copies of AV containing personal affairs (Image /sounds) of third parties."

On 6 May 2021 I spoke with you regarding the scope of the AV material. In an email on the same date you confirmed "AV material from 2021 can be considered."

In relation to the following part of your request:

"Statistical data on how many times tasers have been discharged and or drawn by SA Police Officers... Time period financial years 2016/2017, 2017/2018, 2018/2019 and 2019/2020..."

It is determined to **release in full** data that falls within this part of your request and has been presented in tables below and was correct as at 20 May 2021.
