In reference to your application made pursuant to the *Freedom of Information Act 1991* (FOI Act), access was sought to:

"I AM SEEKING COPY OF RECENT SAPOL POLICY RELATED TO POLICE OFFICER TATTOOS AND RECRUITING PERSONS WITH TATTOOS. I AM ALSO SEEKING COPY OF SAPOL POLICY RELATED TO POLICE FOFICERS (sic) WITH ONE DRINK DRIVING CHARGE AND ONE COMMON ASSAULT CHARGE. I UNDERSTAND THESE ARE POLICY DOCUMENTS. I AM NOT JUST SEEKING THE POLICY, BUT THE ACTUAL START TO FINISH OF THE POLICY AND ANY AND ALL COMMITTEE WORK AND OR SUBMISSIONS FROM THE PUBLIC. I DID NOT KNOW OF THESE POLCIES (sic) AND I DID NOT MAKE ANY SUBMISSIONS TO THEIR INTRODUCTION OR USE OR ANY CHANGES TO THE POLICIES."

In relation to this part of your request:

"I AM SEEKING COPY OF RECENT SAPOL POLICY RELATED TO POLICE OFFICER TATTOOS AND RECRUITING PERSONS WITH TATTOOS."

An excerpt of the General Order, Dress Standards has been considered as the other parts of this document are outside the scope of your request. In assessing the overall structure of the document, I consider the document consists of standing orders relating to multiple different topics. Whilst the document does contain information relative to your application for access, I consider the remaining parts of the document to have no bearing on your application. The fact that the information you seek is contained in the document alongside other unrelated information is solely by virtue of the structure of the document.

While the segments of the document are connected via a common theme; dress standards, I consider it appropriate that each heading be treated as a different entry, similar to a chapter of a book, or an entry of a diary. Without creating a new document, provision of an excerpt of the document in redacted form is the most efficient manner in which to provide the document. I therefore consider the information not marked as out of scope to be the only information within scope of your request.
