**Re: Freedom of Information Act application**

In reference to your application made pursuant to the *Freedom of Information Act 1991*, access was sought to:

*"Documents, specifically reports, statistics, spreadsheets and reviews relating to COVID-19 related fines. I would expect the documents to capture how many fines have been issued since 1 March 2020. I'm specifically seeking access to documents containing the following information:*

- The number and amount in \$ of COVID-19 related fines issued;*
- A breakdown of the types of offences and where and when they occurred;*
- Of those, how many were paid, how many are overdue and how many were rescinded and why.*
- What the money collected in fines is spent on, or where it goes."*

Data falling within the scope of your request is contained on a spread-sheet attached to this determination letter. This information was correct as at 8 November 2021.

**In relation to the following part of your request:**

*"...The number and amount in \$ of COVID-19 related fines issued..."*

It is determined to **release in full** data that falls within this part of your request.

It is determined between 1 March 2020 and 5 November 2021, 2023 fines were issued for breaches of sections 28(1) and 28(2) of the *Emergency Management Act 2004* ('EMA'). The value of those fines (including victims of crime levy) was \$2,501,722 (column F).

**In relation to the following part of your request:**

“...A breakdown of the types of offences and where and when they occurred...”

It is determined to **release in full** data that falls within this part of your request.

On perusal of the data in the spread-sheet you will see that expiation offence codes appear in column C. These codes correlate with specific sections in the EMA. The table below identifies the offences.

Section Number	Offence Description	Expiation Offence Code
28(1) EMA	Person refuse/fail to comply with requirement or direction during major incident or emergency	L031
28(2) EMA	Body corporate refuse/fail to comply with requirement or direction during major incident or emergency	L049

It is determined between 1 March 2020 and 5 November 2021, expiation notices were issued for breaches of sections 28(1) and 28(2) of the EMA. The locations where the offences occurred (column E) and the date the expiation notices were issued (column A) has been included.

**In relation to the following part of your request:**

“...Of those, how many were paid, how many are overdue and how many were rescinded and why...”

It is determined to **release in full** data that falls within the scope of this part of your request.

The data is presented in columns G and H of the spread-sheet. The terminology in those columns mean:

- Courts relief status (*paid*)
- Expiated (*paid*)
- Courts enforcement (pending or enforced) (*overdue*)
- Withdrawn (*rescinded*)
- Invalid (*rescinded*)

I can advise that in accordance with section 17(1) of the *Expiation of Offences Act 1996*, money received by way of amounts due on police issued expiation notices are paid into the Consolidated Account (except for victims of crime levy).

In accordance with the requirements of Premier and Cabinet Circular PC045, details of your FOI application, and the documents to which you are given access, will be published on the SAPOL website Disclosure Log.
