OSS TCG Report 20 June 2022

- **Stadium Management Authority – Use of Cans.** Discussion occurring in relation to the Stadium Management Authority's liquor licence to allow the use of aluminum cans in replace of plastic cups. LEB Prosecution have lodged an initial intervention with further consultation to occur with stakeholders. CBP to be submitted this week once final position settled.

OSS TCG Report 27 June 2022

- **Stadium Management Authority – Use of Cans.** Discussion occurring in relation to the Stadium Management Authority's liquor licence to allow the use of aluminum cans in replace of plastic cups. LEB Prosecution has lodged an initial intervention with further consultation to occur with stakeholders. CBP submitted. A Directions Hearing is set for 1100 hours 27 June.

OSS TCG Report 4 July 2022

- **Stadium Management Authority – Use of Cans.** Discussion occurring in relation to the Stadium Management Authority's liquor licence to allow the use of aluminum cans in replace of plastic cups. LEB Prosecution lodged an initial intervention. CBP submitted. At the Directions Hearing on 27 July the matter has been adjoined to Tuesday 26 August. PASA have indicated they will make a submission (Supported by the Federal Association) for cans to be disallowed. The AOSMA have since emailed OC LEB, advising the use of cans is supported by (AFL, SANFL, Cricket Australia and nominated members of parliament) and seeking to have the matter brought on earlier than 26 August. Depending on the timeliness of PASA's submission the matter may be able to be brought on earlier.

OSS TCG Report 11 July 2022

- **Stadium Management Authority – Use of Cans.** Discussion occurring in relation to the Stadium Management Authority's liquor licence to allow the use of aluminum cans in replace of plastic cups. LEB Prosecution lodged an initial intervention. CBP submitted. At the Directions Hearing on 27 July the matter has been adjointed to Tuesday 26 August. PASA have indicated they will make a submission (Supported by the Federal Association) for cans to be disallowed. The AOSMA have since emailed OC LEB, advising the use of cans is supported by (AFL, SANFL, Cricket Australia and nominated members of parliament) and seeking to have the matter brought on earlier than 26 July. PASA submitted a letter opposing the introduction of cans.

OSS TCG Report 18 July 2022

LEB Prosecution lodged an initial intervention. CBP submitted. Matter has been adjointed to Tuesday 26 July. Following consultation, OC LEB and OC ED are meeting with AOSMA and Minter Ellison Monday 18 July. A CBP will be submitted after the meeting. PCO 2022/1949.

LEB Prosecution lodged an initial intervention. CBP submitted. OC LEB and OC ED met with AOSMA and Minter Ellison Monday 18 July. CBP submitted re agreed position. PCO 2022/1949. Unknown at this time whether the Hearing will still occur on 26 July. PASA advised and not happy.
