Crowd: 36366

Behaviour:

Australian Wallaroos V New Zealand – no issues at all. Crowd approximately 10,000 by the start of the first game and numbers increased steadily up to the second game.

Australian Wallabies V South Africa – crowd numbers significantly more. Only minor issues with behaviour and two OMCG's removed.

The general behaviour of the crowd was considered very good and there were less issues than at a normal AFL game (particularly the Showdown last weekend).

Alcohol induced behaviours:

• No issues in any of the bars or on the Hill. Service of alcohol was well managed and no issues with the introduction of cans.

General comments:

• This was the first Adelaide Oval event where cans served to patrons. The Hill only served light beer in cans and the other bars served beer, cider and spirits in cans. Police were asked to monitor the implementation of liquor cans. No issues reported.

- A pitch invader ⁶⁽¹⁾ was arrested after entering the field of play but was stopped just behind the northern goals area. There was no interruption to play. Adelaide Oval barred for 3 years and he also received a Police Barring Order for 3 months.
- One female removed for possession of cannabis CEN issued.
- The decision to utilise Star Operations and CGTF was sound and will be considered for future events.
