# DRIVER NOMINATION

This Driver Nomination form can only be completed by the expiation notice holder who is the vehicle **owner** nominating the **driver**, or if a company owns the vehicle, an authorised representative of the company nominating the **driver** for any vehicles involved in the commission of a prescribed offence (within the meaning of section 79B of the *Road Traffic Act 1961*). **If you are the vehicle owner and know who was driving you can submit a Driver Nomination form to nominate the driver only. Alternatively, any other defence must be submitted on a Statutory Declaration.** You must complete **all** sections (\* denotes mandatory field). You can complete Driver Nomination's online at [www.police.sa.gov.au/services-and-events/expiations](http://www.police.sa.gov.au/services-and-events/expiations) and email a completed form to [drivernomination@police.sa.gov.au](mailto:drivernomination@police.sa.gov.au) or post to Expiation Notice Branch, GPO Box 2029, ADELAIDE SA 5001. You will receive notification of the outcome of your Driver Nomination.
