**Re: Freedom of Information Act application**

In reference to your application made pursuant to the Freedom of Information (FOI) Act 1991, access was sought to:

*"All reports, all quantitative and qualitative data, and any written and/or electronic correspondence between any officer of SA Police and the office of the Minister for Police, regarding, or resulting from, the trial of ballistic (or stab-proof) vests."*

South Australia Police (SAPOL) has located documents that fall within the scope of your request. The documents are numbered and described in the following schedule. 

**RE: EXPENDITURE AND CONTRACT EXECUTION AUTHORITY APPROVALS  
INCREASE TO ENABLE SAPOL TO PROCURE ANTI-BALLISTIC VESTS  
AS PART OF THE ONGOING REPLACEMENT CYCLE**

The current contract with <sup>EXEMPT</sup> to supply anti-ballistic vests expires on 31 December 2019. SAPOL propose extending the contract for 12 months enabling an assessment of future anti-ballistic vest requirements taking into consideration the soon to commence multi-purpose load bearing vest trial.

Changes to SAPOL's operational requirements, including creation of the Security Response Section has increased the required contract value from \$2,050,000 to \$2,500,000 (GST Inc.) in order to sustain the ongoing replacement cycle of the old vests and the introduction of a new specialist capability into service.

The proposed increase in contract value exceeds the expenditure authority and contract execution authority approval limits of the Commissioner of Police which both currently sit at \$1.5M (GST Inclusive). Accordingly I seek your approval for expenditure and contract execution for the increased value of \$2,500,000 (GST Inc.).

There is no budget impact associated with extension of expenditure authority or contract authority, as SAPOL has sufficient funding for the additional requirements within its approved forward estimates.

Furthermore, in the event that a letter of extension or such other contract variation document is required to be forwarded to the supplier, it is recommended you approve the requested expenditure and contract authorities, and delegate the signing of such documents to the Commissioner of Police.

Following on from the demonstration of the vests yesterday there is one point of clarity we wish to provide ahead of the media conference on Wednesday.

At the briefing yesterday the point was made that when the hard plate is inserted into the trial vests, the ballistic protection level actually exceeds that of current vests. During this conversation one of the current vests was on the table and was used as the point of reference.

However, some regional areas have a ceramic plate which can be inserted to the current vest – that takes the ballistic rating to level 4. That is higher than what the new vests would be with the plate inserted. However SAPOL has assessed the need for level 4 as very low.

It still remains the case that inserting the plate in the new vests gives a higher level of ballistic and stab protection than current soft body armour vests on issue.

I'm advised the issue regarding the ceramic insert in regional vests is addressed in the documents we have provided, but for absolutely clarity I'm restating here.
