Re: Freedom of Information Act application

I refer to your application made pursuant to the Freedom of Information (FOI) Act 1991 in which access was sought to the following information:

"I am seeking incident reports and related photos/CCTV/video footage since 1 January 2014, until the date of this application, on reported physical assaults including sexual assaults, involving students at the following schools..."

In response to our letter dated 30 October 2017 you narrowed the scope of your request to:

"...can we please just limit to sex crimes (ie sex assaults and sex offences) and reduce the timeframe to 1 January 2015 to the date of the application. Please exclude those that are still subject to legal proceedings."

Before dealing with your request it is important to draw your attention to the page numbers on the top right corner of each document. The page numbers relate to the number of pages printed with each batch print run and are not indicative of the number of pages associated with each report.

It should also be noted that images associated with some of the reports have not been dealt with in this determination. It will become clear to you when perusing the nature of the 'offence details' on the reports that images were involved however possession and dissemination of images is an offence. I confirm that searches were undertaken for CCTV and video footage however no documents were located.

South Australia Police (SAPOL) has located documents that are associated with the wording of your FOI application. The documents are numbered and described in the following schedule. The schedule contains the details of the determination in compliance with section 23. In particular, note the grounds on which access has been refused,



including the reasons which are contained in the schedule. This determination was made on 15 January 2018.

		Clause 6(2) – relates to document numbers 1, 2, 4, 5, 6, 8, 9, 10, 11, 12, 13, 14, 15, 17, 18 and 19. It has been considered and the view formed is that a portion of text within these documents are allegations of criminal or other improper conduct on the part of the third parties other than Ms Allison Sandy; the truth of which has not been established by judicial process. The following factors were considered as to whether or not it would be unreasonable to disclose those personal affairs: • The fact is that allegations of criminal conduct are recorded against multiple third parties and the truth of those allegations has not been established by judicial

process;

- The very nature of the information would disclose the identity of the third parties and the fact they were a suspect for alleged criminal offences, the truth of which has not been established by judicial process;
- It was considered improbable that allegations of the third parties being nominated as suspects would be in the public domain; and
- There is a potential for the document to be disseminated to other parties.

Clause 6(3a) – relates to document numbers 1-19.

It is fact that the documents contain information concerning third parties who are presently, or at the time of making the report were, under the age of 18 years and/or suffering from a mental illness or impairment.

The following factors were considered as to whether or not it would be unreasonable to disclose those personal affairs having regard to the need to protect that person's welfare:

- The third parties are extremely vulnerable persons whether it be their young age, impairment of cognitive development or degree of understanding;
- A child or young person's mental and physical health and wellbeing as well as safety is of paramount concern to SAPOL;
- Despite the passage of time victims of crime may remain traumatised so that their psychological wellbeing is compromised;
- Disclosure of their personal

		affairs may undermine a third parties trust in SAPOL and may result in them not reporting crime in the future.

CLAUSES FOR REFUSAL

Clause 6(1) of Schedule 1 of the FOI Act which states:

"A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead)."

Clause 6(2) of Schedule 1 of the FOI Act which states:

"A document is an exempt document if it contains allegations or suggestions of criminal or other improper conduct on the part of a person (living or dead) the truth of which has not been established by judicial process and the disclosure of which would be unreasonable."

Clause 6(3a) of Schedule 1 of the FOI Act which states:

"A document is an exempt document if it contains matter consisting of information concerning a person who is presently under the age of 18 years or suffering from mental illness, impairment or infirmity or concerning such a person's family or circumstances, or information of any kind furnished by a person who was under that age or suffering from mental illness, impairment or infirmity when the information was furnished and the disclosure of which would be unreasonable having regard to the need to protect that person's welfare."

Your rights to review and appeal

If you are dissatisfied with the determination for access to SAPOL records, you are entitled to exercise your right of internal review in accordance with section 29(1) of the FOI Act by completing a PD362 Application for Internal Review form which can be downloaded from https://www.police.sa.gov.au/services-and-events/freedom-of-information or available upon request at your nearest police station. Alternatively an application must be lodged within 30 days from the date of this determination with a fee of \$34.25. Such a fee may be waived in the event of an exemption being claimed.
