**Re: Freedom of Information Act application**

I refer to your application made pursuant to the Freedom of Information (FOI) Act 1991 in which access was sought to the following information:

*"I am seeking incident reports and related photos/CCTV/video footage since 1 January 2014, until the date of this application, on reported physical assaults including sexual assaults, involving students at the following schools..."*

In response to our letter dated 30 October 2017 you narrowed the scope of your request to:

*"...can we please just limit to sex crimes (ie sex assaults and sex offences) and reduce the timeframe to 1 January 2015 to the date of the application. Please exclude those that are still subject to legal proceedings."*

Before dealing with your request it is important to draw your attention to the page numbers on the top right corner of each document. The page numbers relate to the number of pages printed with each batch print run and are not indicative of the number of pages associated with each report.

It should also be noted that images associated with some of the reports have not been dealt with in this determination. It will become clear to you when perusing the nature of the 'offence details' on the reports that images were involved however possession and dissemination of images is an offence. I confirm that searches were undertaken for CCTV and video footage however no documents were located.

South Australia Police (SAPOL) has located documents that are associated with the wording of your FOI application. The documents are numbered and described in the following schedule. The schedule contains the details of the determination in compliance with section 23. In particular, note the grounds on which access has been refused,



including the reasons which are contained in the schedule. This determination was made on 15 January 2018.

### Your rights to review and appeal

If you are dissatisfied with the determination for access to SAPOL records, you are entitled to exercise your right of internal review in accordance with section 29(1) of the FOI Act by completing a PD362 Application for Internal Review form which can be downloaded from <https://www.police.sa.gov.au/services-and-events/freedom-of-information> or available upon request at your nearest police station. Alternatively an application may be made in writing to the SAPOL Freedom of Information Unit. This application must be lodged within 30 days from the date of this determination with a fee of \$34.25. Such a fee may be waived in the event of an exemption being claimed.
