Re: Freedom of Information (FOI) Act application

In reference to your application made pursuant to the Freedom of Information (FOI) Act 1991, access was sought to:

2110

"A table detailing every exemption that has been granted under any of the Directions made since the State Coordinator's 22 March Declaration of a Major Emergency, in accordance with the Emergency Management Act 2004 (SA) for the period of 28 May 2020 to 19 August 2020. The following details are to be provided, where they exist: - Exemption reference number - Date and time the exemption was granted - Date and times the exemption is active for - The conditions of the exemption - Justification for the exemption - Approving authority of the exemption - Location of the recipient of the exemption - Which Emergency Direction had been exempted - Whether the exemption recipient was a corporation, organisation or a natural person."

On 18 September 2020 Sergeant Watson spoke with of your office who confirmed that you wished to exclude the personal affairs of third parties from the scope of your application. Please note that personal affairs have been redacted.

South Australia Police (SAPOL) FOI determination of 9 August 2020 dealt with the same scope, up to and including 30 May 2020, FOI file number 20/2110 refers. This determination has dealt with data for the period between 31 May 2020 and 19 August 2020.

It should be noted that the table detailing *Emergency Management (Cross Border Travel No 7) (COVID-19) Direction 2020* has numbering under the column titled, *EXEMPTION*, however it does not commence until row number 72. A number of rows under the column titled, *EXEMPTION granted under section 5(d)(iii)*, has many entries of the letters 'N/A' as these matters were referred to SA Health. The column titled, *REASONS FOR EXEMPTION NOT GRANTED / REMARKS*, has no entries for many rows as there was either no entry required or no entry was made.



It is determined to release in full data that falls within the scope of your request for the period 31 May 2020 to 19 August 2020. The data has been presented in five (5) tables below. This determination was made on 21 September 2020.

Such a fee may be waived in the event of an exemption being claimed.
