## Dear Ms Sandy

In reference to your application made pursuant to the *Freedom of Information Act 1991* (FOI Act), seeking access to:

"Documents, specifically reports, costs/expenses, correspondence including emails, AV material including CCTV/body-worn camera/video footage, audio, photos relating to wilful damage where your police agency is the victim. Timeframe: Since 1 January, 2021 to the date of the application. Please exclude duplicates, documents that have already been publicly released, media reports/releases/articles and correspondence with media. If emails are captured, please limit to the final thread of the conversation. Please note, I do not consent to information in documents being deemed irrelevant without consultation. However, I do consent to contact details being redacted."

On 20 December 2022, I sent a Section 18 letter requesting you narrow the scope of your request to police reports and audio visual (AV) materials. On the same day you replied via email requesting South Australia Police (SAPOL) remove all reports involving offences of graffiti. I advised there would be 12 reports which you requested all reports and the first five incidents CCTV/body-worn camera/video footage, audio, photos relating to wilful damage.

SAPOL has located documents that fall within the scope of your request. The documents are numbered and described in the following schedule. The schedule contains the details of the determination in compliance with section 23. In particular, note the grounds on which access has been refused, including the reasons which are contained in the schedule.

### Your rights to review

If you are dissatisfied with the determination for access to SAPOL records, you are entitled to exercise your right of internal review in accordance with section 29(1) of the FOI Act by completing a PD362 Application for Internal Review form which can be downloaded from <a href="https://www.police.sa.gov.au/services-and-events/freedom-of-information">https://www.police.sa.gov.au/services-and-events/freedom-of-information</a> or available upon request at your nearest police station. Alternatively an application may be made in writing to the SAPOL Freedom of Information Unit. This application must be lodged within 30 days from the date of this determination with a fee of \$39.00. Such a fee may be waived in the event of an exemption being claimed.
