Re: Freedom of Information Act application

In reference to your application made pursuant to the Freedom of Information (FOI) Act 1991, access was sought to:

"A daily breakdown of Crime, Traffic & Ancillary Reports recorded at Norwood Police Station between 8am and 9am and 5pm and 9pm Monday to Friday. A daily breakdown of Crime, Traffic & Ancillary Reports recorded at Norwood Police Station on Saturdays and Sundays between 9am and 9pm."

It is determined to **release in full** the number of times a report was taken at Norwood Police Station broken down into *8am and 9am and 5pm and 9pm Monday to Friday and Saturdays and Sundays between 9am and 9pm* between 14 November 2018 to 22 October 2019. This data is represented in three tables below and was accurate as of 22 October 2019.


