Re: Freedom of Information Act application

In reference to your application made pursuant to the Freedom of Information (FOI) Act 1991, access was sought to:

"Any and all data, documents and internal correspondence (including, but not limited to, emails, minutes, briefings, letters and notes) regarding: The number of registered firearms that have been stolen, lost or otherwise reported missing in SA between July 2010 and June 2020, broken down into individual years The number of each type or category of firearm that has been reported missing Any other information regarding the nature of the theft or loss of firearms (eg are there particular locations, postcodes, or industries that are more affected). Timeframe 1/07/2010 – 1/06/2020"

On 7 October 2020 Sergeant Watson spoke with scope of your office to clarify the scope of your request. In an email dated 12 October 2020 refined the scope to seeking access to:

"Statistical data regarding the number of registered firearms that have been stolen, lost or otherwise reported missing in SA between July 2010 and June 2020, broken down into financial years. The number of each type or category of firearm that has been reported missing."

In relation to the following part of your request:

"...Statistical data regarding the number of registered firearms that have been stolen, lost or otherwise reported missing in SA between July 2010 and June 2020, broken down into financial years..."

It is determined to **release in full** data that falls within this part of your request and has been presented in tables below.
