 At about 3.41 pm on Wednesday 23rd March 2022 male caused damage to the exterior dome cover of CCTV camera belonging to SA Police. This camera is mounted atop a fixed pole at the rear (drive in) entry of the Elizabeth Police Station complex, outside of the locked fence of the compound. The offence was captured on CCTV, which shows the suspect rubbing what appears to be a lit cigarette against the exterior dome cover, causing the centre of the cover to partially melt and cause visibility issues on the monitor. The exterior dome cover is about 15 cm circumference and the damage covers about 1cm diameter in the centre of the cover. Damage value unconfirmed at this time. Estimated < \$500. Nil permission.
