Re: Freedom of Information Act application

In reference to your application made pursuant to the *Freedom of Information Act 1991* (FOI Act), access was sought to:

"Requesting documents related to youth offending (offenders aged 18 and under) in Port Augusta and the Davenport community near Port Augusta. Including: - The number of youths arrested in Port Augusta and Davenport from May 24, 2022 to May 24, 2023 inclusive and each offender's age. - The number of youths from Port Augusta and Davenport charged with criminal offences from May 24, 2022 to May 24, 2023 inclusive. - The offences any youths arrested in Port Augusta and Davenport from May 24, 2022 to May 24, 2023 inclusive have been charged with. - The number of youths from Port Augusta and Davenport currently on police curfew and what their curfews are. - The number of youths from Port Augusta and Davenport currently on bail. - A month by month breakdown of how many youths from Port Augusta and Davenport have been charged with criminal offences and what the charges are from May 24, 2022 to May 24, 2023 inclusive."

On 16 June 2023, you were emailed and asked to provide further information with regards to the scope of your request. This included identifying the age of a person defined as a 'youth' and the region covered by the Port Augusta and Davenport communities.

On 10 July 2023 you responded via email and confirmed the scope of your request. It was agreed the locality included the broader region of Port Augusta, including Port August West and Stirling North and 'youth' was defined as 17 years and under. Subsequently, it has been determined to **release** the following information to you **in full**.

In relation to this part of your request:

"...documents related to youth offending (offenders aged 18 and under) in Port Augusta and the Davenport community near Port Augusta."

Data is presented for offenders aged 10-17 years at the time of charge, for offences occurring in Port Augusta, Port Augusta West, Davenport and Stirling North (referred to henceforth as the Port Augusta region), for charges laid in the period of 24 May 2022 to 23 May 2023 inclusive.

In relation to this part of your request:

"The number of youths arrested in Port Augusta and Davenport from May 24, 2022 to May 24, 2023 inclusive and each offender's age."

A total of 75 people aged 10-17 years were arrested in the period of 24/05/2022 – 23/05/2023 (age breakdown provided in Table 1) for offences which occurred in the Port Augusta region.

Note that the age breakdown of offenders does not sum to the total number of offenders as some youths were arrested multiple times before and after a birthday within the date period.

In relation to this part of your request:

"The number of youths from Port Augusta and Davenport charged with criminal offences from May 24, 2022 to May 24, 2023 inclusive."

There were 121 youths aged 10-17 years charged (arrested or reported) with criminal offences in the period of 24/05/2022 – 23/05/2023 for an offence that occurred in the Port Augusta region.

In relation to this part of your request:

"The offences any youths arrested in Port Augusta and Davenport from May 24, 2022 to May 24, 2023 inclusive have been charged with."
